Product description

The Gigalight GPP-8514G-SRC SFP+ transceiver is designed to transmit and receive optical data over 50/125µm or 62.5/125µm multimode optical fiber (Table 1).

The GPP-8514G-SRC module electrical interface is compliant to SFI electrical specifications. The transmitter inputand receiver output impedance is 100 Ohms differential. Data lines are internally AC coupled. The module provides differential termination and reduce differential to common mode conversion for quality signal termination and low EMI. SFI typically operates over 200 mm of improved FR4 material or up to about 150mmof standard FR4 with one connector.

The transmitter converts 14.025Gbit/s serial PECL or CML electrical data into serial optical data compliant with the FC standard. The receiver converts 14.025Gbit/s serial optical data into serial PECL/CML electrical data.

Absolute maximum rating

Rate Select Control

RX and TX rates can be independently controlled by hardware input pins RS0 and RS1. Module electrical input pins 7(RS0) and 9(RS1) are used to select RX and TX rate respectively. The flowing table shows the way how to select rate by RS0 and RS1.




Figure 2: Module Contact Assignment

[2].should be pulled up with 4.7k – 10k ohms on host board to a voltage between 3.15Vand 3.6V.

[3]Tx_Disable is an input contact with a 4.7 k Ω to 10 k Ω pullup to VccT inside the module.

[4]Mod_ABS is connected to VeeT or VeeR in the SFP+ module. The host may pull this contact up to Vcc_Host with a resistor in the range 4.7 k Ω to10 k Ω .Mod_ABS is asserted "High" when the SFP+ module is physically absent from a host slot.

[5] RS0 and RS1 are module inputs and are pulled low to VeeT with > 30 k Ω resistors in the module.










Figure3. Host Board Power Supply Filters Circuit




















Figure5. Mechanical Specifications
